License amendments must be filed through the Nationwide Multistate Licensing System (NMLS) (http://www.nmls.org) by amending the applicable Company Form (MU1) and/or Branch Form (MU3). See the Kansas amendment checklists on NMLS for details: Company Amendment and Branch Amendment

Pursuant to the Kansas Uniform Consumer Credit Code (UCCC) under K.S.A. 16a-2-302 (6), no licensee shall change the location of any place of business without giving the OSBC at least 15 days prior written notice. K.S.A. 16a-2-302 (7) states that a licensee may conduct business only at or from any place of business for which the licensee holds a license and not under any other name(s) than that in the license. Supervised Loan Licensees should use their full legal name as stated on their license in all legal documents prepared or used when entering into transactions with Kansas consumers. It is acceptable to include a trade (dba) name that is properly noted on the license in legal documents, as long as the full legal name is also included.

Supervised Loan Licensees assume certain duties and responsibilities under Kansas statutes and regulations. To help ensure compliance, Supervised Loan Licensees are responsible for familiarizing themselves with the UCCC, which is available on the OSBC website at <a href="https://www.osbckansas.org">www.osbckansas.org</a>.
